



# Summer Swim 2009 Registration

Dear River Rat Parents,

Welcome to the Geneva River Rats 2009 Summer Season! Please read through this packet completely before mailing your form.

The success of the River Rat's Summer Program is found in the participation of our scheduled swim meets. A summer meet schedule has been posted on the website and should be looked at carefully. The most important meet of the season is our Conference Championship meet held in DeKalb, IL this year. All swimmers can attend conference if they have participated in 3 or more conference (Dual or Invitational) swim meets. Mark your calendars now; our conference meet is Saturday July 18th. \*The Conference Championship meet is not a requirement for participation in the River Rat's Summer Program\*

Our summer season will tentatively start on Thursday June 4<sup>th</sup> or the first day of summer break for the Geneva School District, and end on Saturday, July 18<sup>th</sup> with our conference meet. Our practices for the summer will be held at Geneva's Sunset Pool and Eagle Brook Country Club. Prior to the season beginning we will distribute a practice schedule for all swimmers loosely based on the 2008 practice schedule (still on the website).

The 2009 Summer Season will begin with tryouts held at Marmion High School on Sunday April 26, 2009. If your swimmer cannot make this date you can make an appointment with Coach Joe in order to be tested. In addition there will be four parent meetings offered this year and are mandatory for all parents as attendance will be taken. Please check the website's calendar for the scheduled parent meetings.

Registration for the summer season begins once this form has reached you. It is important that you understand the **registration procedure** for summer since it is different from past years. With pool space tightening it is very important for us to know the size of our team and the size our age groups. In past years we have received to many forms the week before or week after the season officially starts, this has made it difficult for us to manage our pool space and know the sizes for team t-shirts. **To encourage you to register early, we are providing a discount.** In addition to the registration fees this year we are including \$30.00 fee for meet registrations. The new meet registration fee will provide us with all fees paid up front, thus no surprises.

The following are the 2009 Summer Fees:

- Pre-Registration Date Fee (**before May 17<sup>th</sup>, 2009**): \$250 First swimmer  
\$240 Any Additional swimmer (from same household)
- Post Registration Date Fee (**after May 17<sup>th</sup>, 2008**): \$270 First Swimmer  
\$250 Any additional swimmer (from same household)

Parents may register by writing a check for the full amount owed. An additional option: write two checks splitting your family's fees in half; date one check in April and post-date the second check for June 18<sup>th</sup>, and mail both checks in with the registration form. **Early registration must be postmarked by May 17<sup>th</sup> 2008.** Swimmers may not participate in Summer Swim unless a signed registration form and complete fees have been received.
